

# **Fundraising Terms and Conditions**

#### 1. These Terms of Use

- Mildura Health Foundation Limited ABN 4166 810 2930 (The Foundation, we, us, or our) is a community-based registered charity that was established to raise funds to "acquire, construct maintain and/or operate facilities for the provision of affordable temporary accommodation on a non-profit basis for patients being treated at the Mildura Health Icon Cancer Centre."
- These are our website terms of use (Terms). They set out important information
  that applies to your use of the Foundation website and any of our social media
  channels (collectively referred to as the Website), and form a contract between you
  and us so please read them carefully before continuing to access or use the
  Website.

- <u>Use of Donations</u>: The Donor understands that their Donation will be used to support the Foundation Purpose as stated in the Constitution, and that the Foundation may apply the Donation at its discretion to achieve the purpose. The Foundation is not obliged to use the Donation for any specific purpose, program, or project, unless this has been expressly agreed in writing.
- <u>Tax deductibility</u>: The Foundation is a deductable gift recipient. Donations to the Foundation of \$2 and over may be tax deductible. This will appear on your tax

receipt. If you set up any recurring donations, these will be tax deductible and will be receipted at the end of the financial year.

These Terms are governed by the laws of the State of Victoria, Australia, and we and you both submit to the exclusive jurisdiction of those courts.
